All Members **MUST** check in prior to play. Memberships are not transferable and are non-refundable. The SNGC household memberships shall include Member, Partner and those family members 21 years of age or under currently attending undergraduate school full time. All Members accept and guarantee SNGC that each membership is a contract for twelve months beginning on the Membership Application Date on this form through one year from said start date. Golf Cart Fees are not included (unless a Cart Plan is purchased) and any applicable taxes are the sole responsibility of the Member. All Members must comply with the rules and regulations of SNGC Membership Offering. SNGC reserves the right to amend, modify or supplement these rules, terms, and conditions at any time and without prior notice. SNGC reserves the right to close the course due to outings, agronomic practices, special events or inclement weather conditions as it deems necessary. All Members will use the facility at their own risk and must comply with all club rules. Members may pay the annual dues in full at the prevailing discounted rate of the chosen category or paid through an installment plan. Installment plan requires a \$1,000 down payment at enrollment; and balance payable over the next six months charged to Member credit card on file with an additional 2.5% administrative fee. Rates are subject to change at the first of each month. Cart Rental is required on weekends & holidays until 12:00 pm. Junior Members under the Age of 18 years of age must have the accompanying signature of a parent or legal guardian.
